## **History of CPM**

The possibility of starting a private school in Malmesbury was being investigated by individuals as early as 1996, as there was concern that large classes in the government schools hampered good teaching. On 19 January 1999, the Christian Private School Malmesbury opened its doors, boasting nine learners and three teachers. We are thankful to report that we are still growing in learners every year.

The new teaching dispensation has indeed set new challenges to our community and it is with sincere gratitude that we affirm that the need for alternative education options continues to grow and that our school is going from strength to strength. In 2005, the school expanded with the extension of a Grade R class and in 2011, the playschool Jelly Tots, opened its doors for the 3 – 5 year olds.

Today we are proud to have about 236 learners and 22 teachers at the school. Willie Taylor is our current principal.

## School wear

Clothes are available from the school.

### Winter

School track suit pants with soft shell top, golf shirt and predominantly white tackies with white socks. School rain jacket, scarves, body warmer and beanies.

### Summer

Girls: Blue divided skirt and golf shirt; predominantly white tackies, navy Crocs or bare feet.

Boys: Blue shorts and golf shirt; predominantly white tackies, navy Crocs or bare feet.

### Sportswear

Athletics: Athletics shirt with dark blue shorts

Netball: Sleeveless sport shirt with netball skirt.

Hockey boys: Sport shirt, dark blue shorts (PT shorts) and long dark blue socks.

Hockey girls: Sleeveless sport shirt with skirt(netball) and long dark blue socks.

Tennis: Sport shirt & dark blue shorts (PT shorts).

Soccer: Sport shirt, dark blue shorts (PT shorts) and long dark blue socks.

Cricket: Sport shirt, dark blue shorts (PT shorts) and white socks.

Rugby: Dark blue shorts (PT shorts). Rugby jerseys are provided by the school.

Swimming: Girls – Navy One Piece Swimsuit.

Boys – Navy jammers.

CPM Swim cap available at clothing bank.

Sports bags and school bags are also available.

Learners are expected to wear their school uniform at all times during school hours and also on sport occasions when the learner is not participating.

During the first and fourth terms the learners are requested to wear the official school hat/cap whenever they are in the sun. Gr. 1 – 3: wide brim hat; Gr. 4 – 7: cap.

### **Civvies day**

The following rules apply when casual wear is worn:

- No revealing or see-through clothes may be worn
- No make-up

### **General**

No jewellery may be worn with the school uniform. Legal *Medic Alert* bracelets and watches with an ordinary strap may be worn.

Fingernails must be short and neat, without nail polish.

*Girls:* The girls' hair must be worn in a neat style. No highlights or hair colour are allowed. Long hair (on the shoulder) should be worn in a ponytail.

Hair accessories:

- white, blue and green elastics (school colours)
- white, blue and green Alice bands (school colours)
- silver slides

Fringe must be cut to 1cm above the eyebrows or neatly tucked away. No make-up is allowed. The girls are allowed to wear one pair of matching earrings/studs, gold- or silver-coloured, not more than 1cm in diameter; one per ear lobe. No coloured studs allowed.

*Boys:* The boys' hair should be clean, neat and tidy at all times, in a short haircut. No highlights or hair colour are allowed. Guideline for hair:

- Back - above the collar
- Fringe - 1cm above the eyebrows
- Sides - ears must be open

### **Admission requirements**

1. All children who fall within the required age group for their grade, and who are competent in English or Afrikaans, are admitted. The school reserves the right to have the child take a standardised test to determine his/her efficiency in the preferred language.
2. Learners' parents must fulfil their financial obligations as stipulated in the Terms and Conditions. Learners will be refused admission to the school if parents default in this regard.
3. Learners and their parents must be prepared to abide by the school rules as determined by the Governing Body.
4. Respect for our Creator, ourselves and our fellow-beings forms the basis of the school rules.

## School fees

### Admission fee

Jelly Tots: R500 (deducted from admission fee when registering in Gr. R)  
Grade R: R1 500 if your child enters CPM for the first time. If a child attended Jelly Tots, the Admission fee is R1 000 (you have already paid R500 when child entered Jelly Tots).  
Grade 1-7: R3 000 (new learner)  
Admission fees are non-refundable.

School fees are payable yearly, quarterly or monthly in advance before the seventh of each month for 12 months. Interest will be added on outstanding accounts.

**School Fees**

Enrolment fees are not refunded and payable before the learner is admitted. The school fees are payable in advance: yearly, quarterly or monthly (for 12 months). ## CPM Terms and Conditions

1. Acceptance of Liability
  - 1.1 The persons responsible for the account as set in the application form of the Christian Private School Malmesbury hereby assumes liability for the account, alternatively binds them self as co-debtor and surety for payment of all school fees to the Christian Private School Malmesbury.
  - 1.2 The Guardian, as described in the Application Form, binds them self as surety and co-debtor for the payment of all school fees by the responsible person or any other payments that may arise from this agreement.
2. Terms of Payment
  - 2.1 It is recorded that school fees are determined yearly and the responsible persons are informed of the result in writing.
  - 2.2 School fees are payable monthly, quarterly or yearly (for 12 months) in advance depending on the fee payment option exercised by the responsible person in the Application Form.
  - 2.3 Payments are to be made to the School without any deductions to set off on or before the seventh of every month.
  - 2.4 Admission fees are non-refundable.
3. Breach of Contract
  - 3.1 In the event where the undersigned surety, responsible person or guardian commits a breach of contract of any of the terms of this agreement, the school may in its sole discretion:
    - 3.1.1 Refuse the scholar entry to the school's premises until the breach has been remedied;
    - 3.1.2 Claim damages from the responsible person and / or the surety and guardian;
    - 3.1.3 Take whatever legal steps that may be necessary.
4. General

This Agreement constitutes the whole Agreement between the parties relating to the subject matter hereof. No amendment or consensual cancellation of this Agreement or any provision or term thereof or any Agreement, bill of exchange or other document issued or executed pursuant to or in terms of this Agreement and no settlement of any disputes arising under this Agreement and no extension of time, waiver or relaxation or suspension of any of the provisions or terms of this Agreement or of any Agreement, bill of exchange or other document issued pursuant to or in terms of this Agreement shall be binding unless recorded in a written document signed by the parties. Any such extension, waiver or suspension which is so given or made shall be strictly construed as relating strictly to the matter in respect whereof it was made or given.
5. Jurisdiction

This agreement is subject to South African law.
6. Credit Information

The responsible person, surety or guardian hereby consents to the disclosure and exchange of personal financial information to a credit bureau or financial institution in accordance with the Credit Act 2005.
7. Domicilium

The parties choose as their domicilla citandi et executandi the addresses set out in the Application Form.
8. Legal Fees

In the event where the school takes legal action against the responsible person, he will be liable for all legal fees on an attorney client scale, collection costs and commission, interest and tracing fees.
9. Cancellation

The responsible person undertakes to give the school one calendar month notice, when the learner leaves the school for whatever reason.
